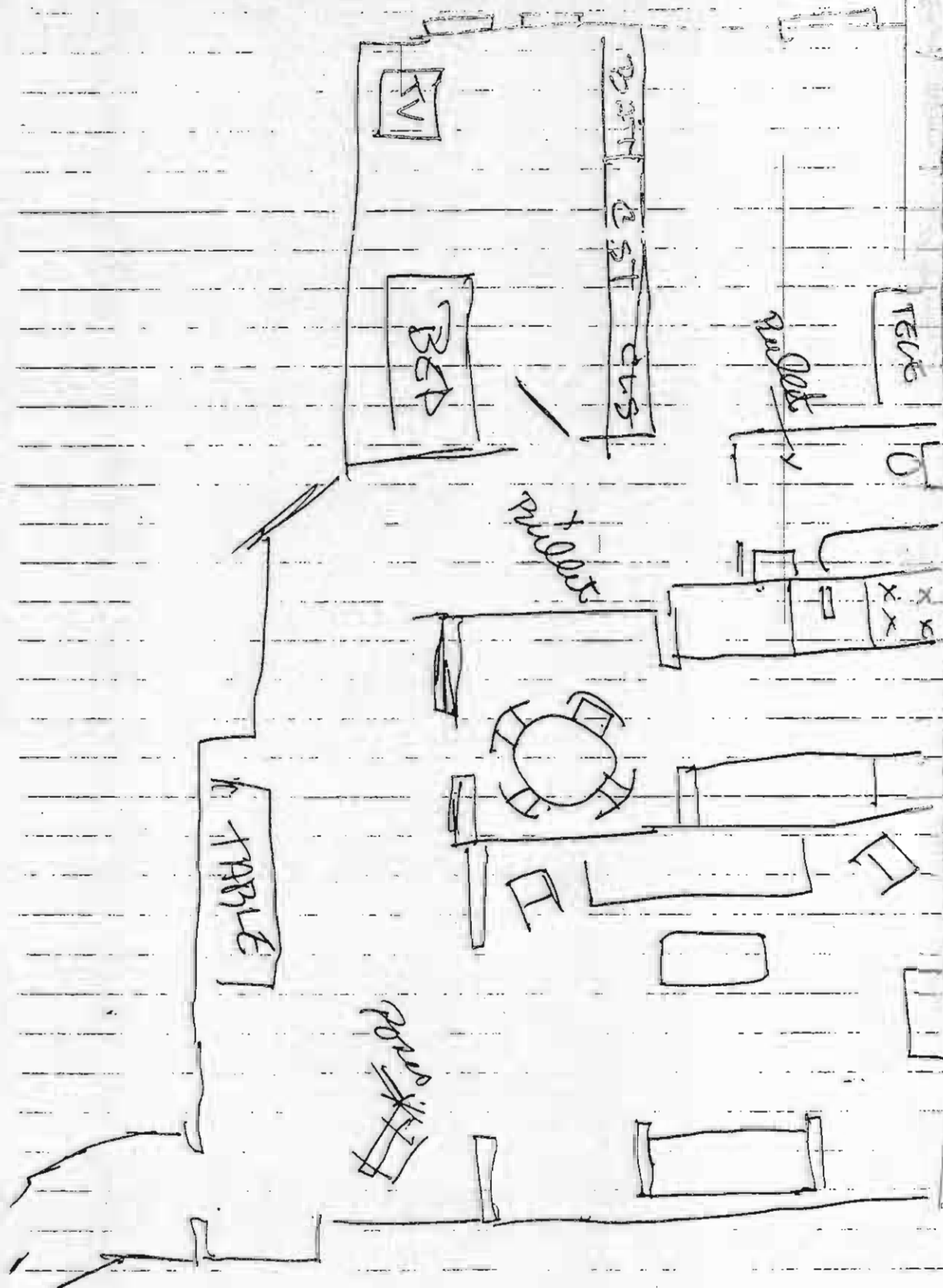

SUMMARY OF CASE On 7/17/90, the undersigned, along with Det. John Atkinson of CSU, responded to the above location, the scene of two persons shot. Upon arrival, the assigned was informed by Lt. Resnick, CO of 34 Det. Squad, that two females described above were both shot in the face by a male, possibly posing as a flower delivery man. A box with a dozen roses with an attached hand written delivery slip were recovered at the scene in the front hallway. 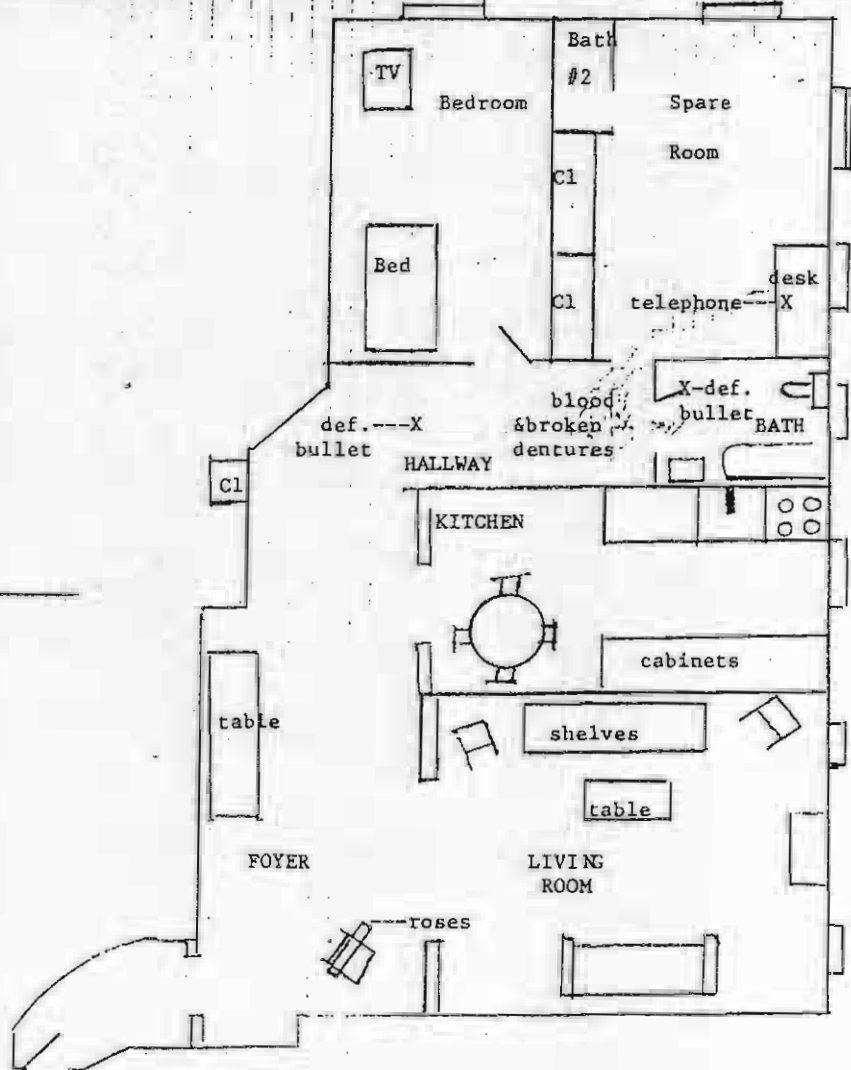
