Subject: FOLLOW-UP RE: HANDWRITTEN NOTE ON BOX OF FLOWERS.

1. Investigation discloses that the perpetrator(s) wanted in this case apparently used a ruse to enter the place of occurrence. Information has been obtained that a box of flowers (one dozen roses) was delivered by the perpetrator and affixed to the box was a handwritten note addressed to the victim, Myra Franza.

2. The note listed the florist as the R & R Florist with a FTD Order #3792. The undersigned contacted FTD (Floral Tele Delivery) at 1-800-621-2556 and was referred to Customer Services - Monica Schmelter at 1-800-521-4366 and after explaining the circumstances of the delivery and the information contained on the slip of paper, Ms. Schmelter stated she was unable to find any listing of an R & R Florist and the order number is not consistent with their format. The slip was zeroxed and a copy is attached to this report.

3. In view of the above mentioned facts and pending further investigation request this matter be continued active.
