2. Examination and comparison of the above described evidence caused the following opinions to be formed:

a. The questioned "Paul Dudley White MD" stamps which were affixed to the evidence Q3 and Q4 can be jigsew matched to the known "Paul Dudley White MD" stamps K14.

- b. The questioned typewriting appearing on the evidence Q1, Q2 and Q5 is consistent with each other but different from the known typewriting appearing on K16A-D, K17A-C, K18A-D, K19 and K20.
- c. Some strong similarities exist between the questioned writing appearing on the evidence Q3, Q4 and the known writing appearing on the evidence K1 K13, K15A-3, K16D and K21 K26.
- d. The questioned writing appearing on the evidence Q5 and Q6 was written by the author of the known writing appearing on the evidence K1 - K13. K15A-B. K16A-D and K21 - K26.
- 3. If testimony is required, it is suggested that this examiner be notified at least ten (10) working days prior to such testimony. This is necessary to prepare the proper exhibits for court presentation.
- 4. The evidence described above will be retained in the files of the Police Laboratory's Document Unit for future reference.
