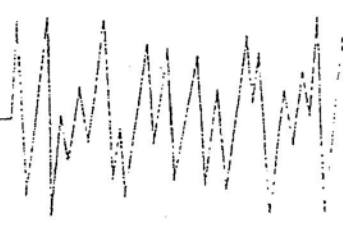

SPECIFIC POLYGRAPH EXAMINATION/S RE: July 17, 1990 Shooting

On 8/9/90, Dominic Franza voluntarily came to this polygraph suite for a polygraph examination.

The main issue under consideration was whether or not Mr. Franza was telling the truth when he claimed that he had no guilty knowledge of nor had he participated in a shooting that occurred on July 17, 1990. The victims of the aforementioned shooting were Mr. Franza's wife Myra and his mother-in-law Josephine Mendez.

The facts concerning this case were provided the polygraphist by Dominic Franza.

Before his pre-test interview, Mr. Franza voluntarily signed two copies of a permission form stating that he was taking the examination of his own free will. One copy of this executed form is enclosed with this report; the other has been incorporated into our case file.

In the polygraph recordings, there were indications of truthfulness when Mr. Franza answered "NO" to all four of his pertinent test questions, which were:

1. On July 17th, at 3:00 PM, did you then already know Myra was going to hurt?
2. Did you shoot your wife Myra?
3. Did you plan with anyone to have your wife or mother-in-law hurt?
4. Did you plan with anyone to have your wife Myra shot?



It is the opinion of the polygraphist, based upon the polygraph examination of Mr. Franza, that he is telling the truth to his pertinent test questions.

In order to maintain high validity, the polygraph examination procedure is usually restricted to four pertinent test questions. The above four were selected by the polygraphist as being the four best test questions to ask in order to bring out either the truthfulness or lying of Mr. Franza about the main issue under consideration.



Gene T. Sandacz received his formal polygraph training in 1967 from Richard O. Arther at The National Training Center of Polygraph Science.

Following his formal polygraph training in 1968 he completed his internship and received his certificate as an expert polygraphist.

From 1966 to 1969 he was employed by a major U.S. corp. as Corporate Security Supervisor and later as the Senior Polygraphist. He was responsible for security and polygraph operations in seven states and supervised a security and polygraph operations in seven different states and supervised a security department of over 250 investigators, including five polygraphists.

In 1969 he was taken into the firm of Scientific Lie Detection in New York City as Mr. Arther's Chief Associate.

While at Scientific Lie Detection he was selected to do research for the oldest and largest-circulation polygraph publication, The Journal of Polygraph Science. In 1969 he was appointed research editor and is currently editor of that same prestigious publication.

From 1969 to present, Mr. Sandacz has served on the faculty of the National Training Center of Polygraph Science. At the National Training Center he has given basic polygraph training to over 800 polygraphists. This includes various state and local law enforcements agencies, several governmental agencies, as well as the Royal Canadian Mounted Police. He is currently Chief Instructor at the National Training Center and sits on the Board of Ethical Conduct.

Mr. Sandacz was President of the New York State Polygraphists from 1975 to 1977. From 1970 to 1980 he served on either the board of directors or as board chairman. In 1973 Mr. Sandacz was elected a Distinguished Fellow in the Academy of Certified Polygraphists. In 1974 he was appointed to the Board of Directors and is currently the Academy's Chairman of the Board.

Mr. Sandacz belongs to other professional organizations including the American Polygraph Association, the Polygraphists of New Jersey, the Society of Investigators of Greater Newark, the Sussex County Peace Officers.

Mr. Sandacz has lectured at various colleges and universities, including Fordham University Law School. Mr. Sandacz has received acclaim for his work in the polygraph profession, including commendations from the United States Marine Corps, the Royal Canadian Mounted Police, and Bertram Roberts of the Bronx County District Attorney's Office.

Mr. Sandacz remained with Mr. Arther and Scientific Lie Detection from 1969 to 1978.

In 1978, Mr. Sandacz became president of Certified Polygraph, Inc. in New York City. Mr Sandacz is also president of In-Depth Interviews, Inc..

I fully realize that: I am not required to take this examination, I may remain silent the entire time I am here, anything I may say can be used against me in any court of law, I may first consult with an attorney or anyone I wish before either signing this form or being interviewed and/or taking the examination, I may have an attorney present, if I cannot afford an attorney and desire one an attorney will be appointed for me prior to any questioning, and I have the opportunity to exercise all these rights at any time I wish during the entire time I am here. Nevertheless, I consent to the use of electronic hearing and recording devices, and I voluntarily request and authorize Certified Polygraph, Inc. to now proceed with the actual interview/examination.

I do hereby authorize Certified Polygraph, Inc. its directors, officers, employees, and/or agents to disclose both orally and in writing the interview/examination results and opinions to directors, officers, employees, and/or agents of DOMINIC FRANZA or persons at interest.

I am fully aware that the opinion may be that I have not been truthful. Nevertheless, in consideration of and as an inducement for Certified Polygraph, Incorporated, to give me this interview/polygraph examination, I -- for myself and my successors, assigns, heirs, executors, and administrators -- knowingly hereby totally release, absolve, remise, covenant, promise, agree to save harmless, waive, forever discharge, and hold free from all harm, liability, or damage whatsoever Certified Polygraph, Inc., the abovenamed, and their respective directors, officers, employees, and agents individually, collectively, and personally from any and all suits, actions, or causes of action at law, claims, demands, or liabilities whatsoever either in law or in equity including but not limited to false arrest, false imprisonment, libel, slander, or invasion of all my rights which I, my successors, assigns, heirs, executors, or administrators have now or may ever have resulting directly, indirectly, or remotely from being interviewed/examined, possible liabilities or damages flowing from the operation of all electronic hearing and recording devices, the rendered oral and written opinions and statements, and/or all future actions taken by any and/or all of the above based upon taking this interview/examination.
